- We do not sell, share, rent, or transfer your SMS opt-in data or consent to any external organizations under any circumstances, even with consent, except as required by law. SMS opt-in data and consent are used solely for LFG Homes communications.

- We maintain administrative, technical, and physical safeguards designed to prevent unauthorized access, use, disclosure, alteration, or destruction of your personal information. These safeguards include limiting access to personal information to authorized personnel and service providers who need the information to perform business functions on our behalf.
